# Green Space and Recreation, Leisure and Wellbeing draft policy

Discussion took place about the content and title of this policy. The consensus was that the Chapter now has a working tile of Green Spaces, Recreation and Leisure. A list of Frodsham's current green spaces was tabled based on a combination of the spaces identified from public consultations, those owned by FTC together with spaces identified in the Masterplan report. The information from the Locality Guidance on designating green spaces in NP's and the NPPF "Policy and Criteria for Green Spaces" was discussed. Several additional suggestions for green spaces were identified. GH to update the tabled list for further discussion at the next meeting.

#### Draft Policies and forward plan

The forward plan set a deadline of the end of November for draft policies to be ready to send to Gill Smith for initial review. Everyone present agreed work should focus on producing the draft policies. A revised format for policy writing was tabled that included "aspirations" at the end of each section. MM noted that Tarvin's "made" Plan was not written to a specific format and was very readable. An additional meeting for authors to review draft policies will be held on 22<sup>nd</sup> October at 6.30 – 8.30pm at the Leisure Centre.
